1. If the entire fee of a student is deposited at the time of admission, 10% concession will be given in tuition fee .
2. If any student discontinues the bus facility in the Mid Session, The bus will not be exempted in any condition, Rs. 20/- per month will be charged as a fine if student is default .
3. If fees will not be deposited before 10th of every month, the student will be declared as defaulter .

5. If two, real brothers or sister are studying in the school 10% concession in tuition fee will be given to the younger one's fee .
6. If students will take admission in the month of July, he /she will have to deposit four month prior fee (April to July)at the time of admission .
7. Bus fee for 11months will be changed .
8. Case pertaining to refund of fees will not be subject to litigation . Fee once paid will not be refunded in any case .
